- 45.9.5 The draft 2023-24 budget was considered. Additional items to include were: newsletter £900 – PC/laptop £750 - Playing field benches £500 - one bench is in need of replacement.
- 45.10 **Phone Box**

A culvert / drain map was requested from Highways on 4/7/22 with no response. Clerk to chase. The village response was to retain the K6 kiosk as a listed feature and not to purchase and restore. (For information; cost of K6 kiosk purchase: nominal £1 and approx. repair costs of £1,000).

- 45.11 **Highways / Vegetation** – reported overgrowth vegetation at the bridge did not need cutting currently.
- 45.12 **Flooding**
- **45.12.1** Silkmead has been flooded and is being monitored there has been no reported flooded highway.
- 45.12.2 Cave Gate scheduled for Highway works with an unknown date. No recent issues due to lack of rainfall apart from September when there was a collection of water on the highway. Clerk to write to CC Jones (completed 4/10/22).
- 45.13 Social Housing and Moatside

Clarion Housing confirmed that no new social housing residents were being accepted at Moatside but an interested village resident was informed he could put an offer in. No. 8 has been derelict for several years and it is likely that the bungalows will be sold. Chairman has written to the land registry for a copy of the Beddington conveyance and governance 1972 documentation.

- 45.14 Playing Fields – no maintenance works are due following the playing equipment inspection on 21/09/22. Three hooks are missing from the new goals – Cllr Bagnall to investigate different hooks that can't be removed. Tree surgery to be arranged; three quotations will be obtained. All councilors were RESOLVED to request works to be carried out by Chris Hart if the quotation was in line with others obtained. One bench needs repair/replacing; Cllr Bagnall agreed to investigate if repair was possible.
- 45.15 Church – the next fund raiser quiz will be held on 22 Oct-22 at the Village Hall and will be publicised.
- 45.16 School / Parking

No current issues, although some parking problems still occur at school start/finish times.

45.17 Queen's Platinum Jubilee:

It has been agreed that the jubilee tree will be planted opposite Anstey Hall, called Lilibets Oak.

45.18 Village Hall

> All exercise classes continue to run, with small but acceptable number attending. The school uses the Hall as and when required. Following a summer break, the Film & Social Club will resume with a screening of Operation Mincemeat on Friday 7th Oct.

> New windows have been installed in the toilet areas, and new flooring to much of the lower level. The Committee are pleased with these improvements and would like to thank the Parish Council for their assistance in this regard. We would very much like to move forward with the car park improvements, though need additional quotations before we can proceed.

> The Committee are planning to celebrate the Hall's 40th anniversary on Sat 19th Nov-22. As per the upcoming Newsletter, 'We can promise live music (with an '80s flavour) from Sky West and Tony Pledger, a hot supper with licensed bar, and plenty of opportunity to catch up with friends and neighbours'.
