He noted correspondence to Highways regarding flooding at The Well, and Highways response that works were scheduled in for the next financial year. HCC have allocated a further £1m in the next budget specifically for flooding issues which may help with the work required at The Well. The new funding is allocated for flooding issues across Hertfordshire. CC Jones confirmed he will monitor the budget allocation. Councillors confirmed that a drain may be blocked or collapsed at the Well and flooding is reported to HCC. It was noted that no drainage is being cleared within the village.

- a) The Well was discussed in 59.3 above reported as a blocked culvert.
- b) Silkmead flooded during snowfall there is an overgrown culvert.
- c) Cave Gate still requires a gully dug but it is somewhat improved if a gully cannot be arranged, permanent signage may be worthwhile. It has been reported some 20+ times and remains a concern when water is across the road.

Villagers may not be aware that Anstey no longer have an employed litter picker and residents could be encouraged to pick up litter if out walking. A local litter-pick will be arranged for Saturday, 29th March at 10am.
