62.1 Apologies received:

Apologies were received from Councillors Simon Bagnall and Amanda Parker, PCSO Glen Stanway.

62.2 Personal / Prejudicial Declarations : None received/raised.

62.3 District Councillor Comments:

<u>Refuse Collection</u>: Stickers have been issued for the purple bins, along with a leaflet explaining the changes. However, it remains unclear when the new system begins in three weeks' time, and at what point in the collection cycle residents will be—whether it will be blue/black or purple bin collection week.

<u>Village Litter Bins</u>: DC Williamson has been investigating the situation regarding the missing litter bins but has not received a definitive answer. Four bins were previously in place:

- 1. One bin was mistakenly removed and has now been replaced with a larger bin near the school.
- 2. Earlier this week, another bin was reinstated on the opposite side of the school.
- 3. The bin near The Well, which is frequently used by walkers, dog walkers, and cyclists, has not yet been replaced. This leaves one bin short. Drew, the Officer responsible, is currently on leave and is expected to return tomorrow. The Council has offered to provide an additional bin for its own use, which would be emptied by the Parish Council.

<u>Playing Field Bins</u>: It was proposed that the bins inside the playing field be removed and signage installed at the entrances to indicate where bins are located.

62.5 Police

There were no reported incidents reported in Anstey. While some neighbouring villages are included in the new policing area, we are unable to reference nearby crimes directly. However, it is worth noting that a significant burglary recently took place in Great Hormead. **Action**: Caroline Jones to ask Glen whether it would be possible to receive a more localised crime report that includes Anstey and its neighbouring villages.

There are now four weekly classes running, including table tennis, carpet bowls, yoga, and the newly added Tai Chi. The projector, which has been in place since 2016, is due for replacement. It has supported nine film nights annually, as well as school classes, presentations, workshops, and church group activities. Unfortunately, the most recent film night had to be cancelled at short notice. The hall is also seeing increased use by the school, following the appointment of a new Head Teacher.
